## RELEASE AND WAIVER OF LIABILITY

**PLEASE READ CAREFULLY!**

**THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS!**

This Release and Waiver of Liability (the "Release") is executed on this \_\_\_\_\_ day of \_\_\_\_\_, 2023 by \_\_\_\_\_ (the "Volunteer") in favor of **MCL Rods and Hogs Car Show**, and all organizations participating therewith, including but not limited to, Marine Corps League, Women Marine Association, Blount County Sheriff's Dept, City of Alcoa, TN, Midland Shopping Plaza, Alcoa, TN, American Red Cross, United States Marine Corps, and all other participating organizations, their directors, officers, employees and agents (collectively, "MCL Rods and Hogs Car Show").

The Volunteer desires to work as a volunteer for Rods and Hogs Car Show and engage in the activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities will include, but not be limited to, preparation, conducting, and termination of the Rods and Hogs Car Show for the year 2023.

The Volunteer hereby freely, voluntarily, and without duress executed this Release under the following terms:

1. **RELEASE AND WAIVER.** Volunteer does hereby release and forever discharge and hold harmless MCL Rods and Hogs Car Show and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Car Show. Volunteer understands that this Release discharges MCL Rods and Hogs Car Show from any liability or claim that the Volunteer may have against Rods and Hogs Car Show with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's Activities with Car Show, whether caused by the negligence of MCL Rods and Hogs Car Show or its officers, directors, employees, or agents or otherwise. Volunteer also understands that Rods and Hogs Car Show does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.
2. **MEDICAL TREATMENT.** Volunteer does hereby release and forever discharge Rods and Hogs Car Show from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with Volunteer's Activities with the Car Show.
3. **ASSUMPTION OF THE RISK.** The Volunteer understands that the Activities include work that may be hazardous to the Volunteer, including but not limited to, constructing and deconstructing the Car Show site, providing transportation for participants and other personnel, loading and unloading supplies and equipment, directing on-site parking, food preparation, rendering first aid and various other tasks or services at the Rods and Hogs Car Show site. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Rods and Hogs Car Show from all liability for injury, illness, death, or property damage resulting from the Activities.
4. **INSURANCE.** The Volunteer understands that, except as otherwise agreed to by Rods and Hogs Car Show in writing, Rods and Hogs Car Show does not carry or maintain health, medical, or disability insurance coverage for any Volunteer.
5. **OTHER.** Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Tennessee, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Tennessee. Volunteer agrees that in the event that any clause or provision of this Release shall be held invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of the Release which shall continue to be enforceable.
